Note: Entries submitted by Australia Post must include a valid email address so a copy of the vet checklist (certificate of fitness for the event) can be forwarded and then completed by your Veterinarian.

Note: Entrants must include on the entry form whether they are riding a bike or running. All handlers, if not the owner of the dog, must also be members of Dogs Victoria or other state affiliate and the handler's membership number included on entry.

**ENTRIES** to be on prescribed entry form and must be legible with correct spelling of dog's pedigree/registered name and include all dog's titles so correct details of entry can be included in catalogue.

This event is **open to all breeds registered on the main, limited and associate registers**. In compliance with ANKC Rules dogs required ages are: minimum 2 years to under 8 years *on the day* of the test and all handlers are required to wear a Hi Visibility vest for the duration of the test.

The GSDCV reserves the right to hold a ballot in the event of an excessive entry a ballot may be held or to provide an additional judge. If a ballot held, this will be drawn at 7pm at the Gippsland Branch clubrooms (**The Canal Reserve (Sunday Market Grounds) Punt Lane, Sale**)

**SPECIAL CONDITIONS:** All entrants who choose to ride a bicycle must wear a suitable safety helmet to comply with the State traffic laws. All bicycles must be in roadworthy condition.

In compliance with the ANKC Rules a veterinary certificate issued within fourteen days immediately prior to the date of the test **MUST BE SUBMITTED FOR EACH DOG ON THE DAY OF THE TEST**.

**CHECK IN:** 8.30am to 9.00am. Dogs to be vetted by the Trial Veterinarian prior to the 9.30am commencement time of the trial

**JUDGING COMMENCES:** 9.30am. **PLEASE NOTE THE CHANGE TO STARTING TIME.**

**AWARDS:** Title ribbons and Pass cards and sponsor product.

**CATERING:** Limited catering will be available.
