## \*\*\*\*\*EXHIBITORS PLEASE NOTE\*\*\*\*\*

All Exhibitors must abide by the COVID Safety Plan that has been agreed with the ACT Government to allow these shows to be conducted.

### CONDITIONS OF ENTRY

- If you have even mild symptoms, please stay away and get tested. Attendees will have their temperature checked on showground entry.
- **All parking will be in the Well Station Road entry carpark.** There are disabled car parks close to the upper entry.
- Attendees are encouraged to have downloaded the COVIDsafe app at <https://www.health.gov.au/resources/apps-and-tools/covidsafe-app>
- Entries are restricted to ACT and NSW residents only.
- Entries will not be accepted from any current 'Hot Spot' as indicated by NSW Government advice available at <https://www.nsw.gov.au/covid19/latest-news-and-updates> or from a high risk category as per the current ACT Government advice at <https://www.covid19.act.gov.au/home>
- Online entries only via Show Manager and will require acceptance of terms laid out in the COVID19 page to enable attendee tracking.
- All persons who are not officials or exhibitors must register their attendance at the office.
- There will be no paper catalogues issued at this event.
- There will be no place ribbons available at this event.
- The catalogue will be emailed to exhibitors prior to the event.
- Lapel card numbers will be emailed to the exhibitor but can be picked up on the day. It shall be the exhibitor's responsibility to print their own exhibit numbers.
- Gazebos must be spaced a minimum of 1.5 metres apart.
- Only members of the same household can share a gazebo.

### PHYSICAL DISTANCING

- There shall be no congregating or setting up on pathways or under ring awnings.
- Keep a distance of 1.5 metres between yourself and other people.
- Practise good hygiene at all times.
- No person shall encroach on the Steward's safety zone (1.5 metres)
- Masks are encouraged.
- Hand sanitizer will be available, but exhibitors should bring their own. Exhibitors shall enter the ring area via the entrance and depart via the ring exit maintain physical distancing at all times.
- Ring equipment shall be regularly sanitized during the event.
- Cleaners will regularly maintain hygienic conditions in the restrooms. Exhibitors are requested to maintain appropriate hygiene and physical distancing when visiting restrooms.

### JUDGING

- There shall be no sweepstakes at these shows.
- Exhibitors shall stand at arm's length from their exhibit as it is being examined by the judge, to assist in maintaining physical distancing.
- The exhibitor shall be responsible for mouthing their exhibit.
- The exhibitor will be responsible for adhering to physical distancing requirements when in the ring with other exhibitors and exhibits.

### CAMPING

- Camping facilities are available at the dedicated Exhibition Park in Canberra (EPIC) camping area.
- **Please note** this is not the usual area allocated for dog show camping and is some distance from the dog rings.
